You will receive a confirmation email to your nominated email address confirming your arrangements and salary packaging start date, taking into consideration any payroll cut-off dates.

Salary packaging

You can choose to salary package your living expenses by either using a salary packaging card, or by reimbursement.

When using a card, your packaged funds will be deposited for regular spending on to the Visa debit card issued by Beyond Bank.

If you choose to package by reimbursement, we will deposit your payment directly to a nominated bank account on presentation of sufficient evidence.
